

**Town of Garfield
TOWN COUNCIL
REGULAR MEETING MINUTES
Town Hall – May 23, 2018**

CALL TO ORDER: Mayor Jarrod Pfaff called the regular meeting of the council to order at 7:00 pm.

ROLL CALL: Mayor Jarrod Pfaff, David Ulrick, Neal Leon, Cande Hasenoerhl were present. Staff: Clerk – Nancy Whitesell, Public Works – Shon Clark and Mark Phillips

GUESTS: Police Chief Jerry Neumann, Sonya Hall, Sandee M. Powell – ATVP, Dan LeBeau – Judicial candidate, Sandy Jamison – Auditor candidate

APPROVAL OF MINUTES: David Ulrick asked for the term unanimously be removed from the approval of minutes on the May 9th minutes draft. Cande Hasenroehrl **MOVED** to approve the minutes of the previous meeting, Neal Leon seconded, the motion carried unanimously.

VISITOR COMMENTS:

Sandee – Introduced herself as the new advocate for the Crime Victim Service Center at Alternatives to Violence. Left brochures and explained types of assistance that they offer

Dan – Introduced himself as a candidate for District Court Judge. He spoke about his background and answered questions brought forward by council.

Sandy – Introduced herself as a candidate for County Auditor. She spoke about her background and qualifications for the job.

Sonja – Asked about possible repairs to the dumpster that sits behind her store. Shon asked her to contact him about the situation.

POLICE DEPARTMENT REPORT: Police Chief Jerry Neumann was available to report.

- 1) May Day was quiet – no arrests
- 2) 1 arrest for DV – neighborhood disagreements
- 3) PD has lots of cones for May Day and were able to close all of California St for parade, transfer of cones went well.

PUBLIC WORKS REPORT: Shon Clark reported.

- 1) Finished water leak at 507 Union and added topsoil
- 2) Added chlorine at Well 3
- 3) Flushed fire hydrant at 7th and California due to water complaints
- 4) Burned off cattails in polishing cell at sewer plant
- 5) Delivered 2-yard rental dumpster and since have picked it back up.
- 6) Garbage has been picked up on time with minimal complaints

- 7) Wants to start with a personal thank you to all residents and business persons for great cooperation thru the stripe painting process as it went off without a hitch and California street looks good
- 8) Swept California Street and in areas around California St and areas around the park
- 9) Park has been getting mowed in a timely manner and looked good for May Day festivities.
- 10) New car charging station has been installed.

OLD BUSINESS:

- 1.) Cande Hasenorehl asked about the progress of the speed signs. Nancy Whitesell stated she was working with the vendor to get the signs ordered.
- 2.) Neal Leon gave Public Works an 'atta-boy' for the sweeper and the stripes on California St. that had been done. Also discussed getting a quote for center stripes on the street.
- 3.) Bids back from Palouse Hills Lawn and Shrub Svc and Leland Lawn for vegetation weed control of the Park. After discussing prices, Cande Hasenorehl **MOVED** to accept Palouse Hills bid at \$885.00 as opposed to Leland Lawn at \$1730.19, Neal Leon seconded, motion passed unanimously.
- 4.) Mayor Pfaff asked that he be placed as the authorized signer for the loan for the purchase of the trailer park. As soon as that happens, he could get the processed finalized. David Ulrick **MOVED** to have Mayor Pfaff be the authorized signer, Cande Hasenorehl seconded, motion carried.

NEW BUSINESS:

- 1.) David Ulrick brought up the old picnic tables in the park. Mayor Pfaff stated that he and Shon had been discussing replacing them, and that it was on their list of items to do. He wants Rick Wride to look at them first. Shon stated he would like the red wood one to be removed as it is beginning to rot. David agreed, and Shon will remove the table.

FINANCIAL: Neal Leon **MOVED** to pay the bills, Cande Hasenorehl seconded, and the motion carried unanimously.

EXECUTIVE SESSION: Cande Hasenoerhl **MOVED** to begin Executive Session to discuss personnel issues. Neal Leon seconded, motion carried unanimously. Council returned to regular session at 7:55 p.m.

ADJOURNMENT: Cande Hasenorehl **MOVED** to adjourn the meeting at 7:55 p.m., Neal Leon seconded, and the motion carried unanimously.
